The inquiries so far have been interesting.

Instantly, the price of everything doubled, as there were now *two* households to sustain.

And as the forced separation and sanctions continued, that deficit began to accelerate exponentially.

the office space, the warehousing, the staff, raw materials, doubled.

I, seen through the eyes of evil as nothing more

*must mean **I can ban my wife, by threat of arrest**, from participating in trade shows, conferences, performance events, and family gatherings too, pretty much anywhere I, as the one filing against her good faith and honor, don't want her to be...*

especially if I want to take those evil spirit voices up on their offer and have as many women as I want and just completely throw my good faith example of a great husband and dad completely into the hands of random women who would actually hook-up with a man over fifty,
